## **ENVIRONMENTAL POLICY**

With the adoption of an Environmental Management System conforming to the international standard UNI EN ISO 14001, ARTIGO S.p.A. has formalised its commitment and own awareness of environmental issues, with the ultimate aim of maintaining its environmental performance over time and, where possible, of consolidating it by defining specific, targeted objectives for improvement. The Company is therefore focussed on and committed to:

- acting at all times in compliance with national and regional laws, as well as applicable regulations and standards, paying particular attention to continually updating environmental requirements; in particular the reference regulations and standards for the company are:
  - industry technical standards: EN 1817, EN 12199, EN 1816, EN 14041 (CE marking) for the European market, ASTM F 1344, ASTM F 1859 and ASTM F 1860 for the American market.
  - European environmental regulations: Regulation (EC) no. 1907/2006 of the European Parliament and of the Council of 18 December 2006 (REACH); Regulation (EC) no. 1272/2008 of the European Parliament and of the Council of 16 December 2008; Regulation (EU) no. 517/2014 of the European Parliament and of the Council of 16 April 2014 on fluorinated greenhouse gases and repealing Regulation (EC) no. 842/2006.
- managing all environmental aspects related to its own activities/products/services in order to contribute to protecting the environment and preventing pollution and, where considered necessary, formalising specific operating procedures and/or targeted programmes and objectives with a view to continual improvement;
- ensuring that all people who carry out duties for or on behalf of the Company that may have a
  considerable environmental impact (personnel, suppliers, etc.). have adequate competencies,
  through appropriate training and experience;
- engaging with all parties concerned, as regards its own environmental policy and commitment to continual improvement.

To achieve the above, the Company is currently involved in the following activities to manage its own environmental aspects:

- ✓ optimising waste management through the separate collection of different types of waste;
- ✓ monitoring data on the use of natural resources (water, electricity and fuels), in order to set up an archive over time to identify/prevent any waste and, where possible, reduce use;
- ✓ monitoring raw materials used in the production process;
- ✓ planning maintenance for plants that impact the environment (suction plants, heating and conditioning systems, compressors, etc.) in order to reduce possible impact on external factors;
- ensuring that work places, including outdoor areas, are kept clean and tidy at all times, in order to reduce overall visual impact.

THE Company maintains a functioning environmental policy, disseminating it to employees, key suppliers and customers, and to anyone requesting it for justified reasons, so it may engage at all times with parties concerned as regards the management of its own significant environmental aspects and monitoring of relative performance.
